The City of Duncombe relies on a three-cell lagoon wastewater treatment system. Its collection system has not been upgraded since 1966, leading to failing lagoon cells, the deterioration of the bottom of the lagoon's secondary cells, and the existing cells having limited capacity due to sludge build-up and sloughing corners. Upon review, Veenstra & Kimm, Inc. identified that limited intercell and discharge piping, as well as select existing structures, are in disrepair. Furthermore, the City must ensure compliance with new Ammonia Nitrogen discharge limits under NPDES Permit No. 9427001, effective February 1, 2026. How the proposed activities will be funded and sources of funds. The City will apply for Community Development Block Grant (CDBG) from the Iowa Department of Economic Development and the balance will be paid with State Revolving Loan Funds (SRF), and additional city funds (if needed). Date application will be submitted. Before 11:59 p.m. on January 1st, 2025. Requested amount of Federal funds. The City will request approximately \$500,000 in Federal funds from the IEDA CDBG Water/Sewer Fund, which includes \$20,000 for administration and \$480,000 for construction, engineering, and related costs. Estimated portion of Federal funds requested that would benefit persons of low and moderate income. The proposed project will benefit the entire City of Duncombe. Approximately 52.1% of Duncombe's population is considered low and moderate income, so that is the estimated LMI percentage that will benefit from this project. Approximately \$260,500 of CDBG funds will benefit LMI persons. Where the proposed activities will be conducted. Sludge removal and rehabilitation of the bottom of the secondary cells and the corners of the lagoon will occur within the 3-cell lagoon located North of Boise Street, along the unnamed creek that flows into Brushy Creek. All deteriorated structures and piping that will be addressed are located within the existing footprint of the city's lagoons.
